Proof of a connection must be submitted if the name on the IRS Form 2290 does not match the name on either the IRP Firm or the vehicle abstract list. Examples of a connection include a corporation screen print, a SAFER screen print, or a lease agreement. We will not accept a 2290 from a previous owner.
